
Respondents object to Appellant’s seventh (7<sup>th</sup>) motion for an extension. South Carolina courts have the inherent power “to manage their own affairs so as to achieve the orderly and expeditious disposition of cases.” Collins v. Sigmon, 299 S.C. 464, 468, 385 S.E.2d 835, 837 (1989)(citing Link v. Wabash R. Co., 370 U.S. 626, 632, 82 S. Ct. 1386, 1389, 8 L. Ed. 2d 734 (1962)).

Appellants have filed their eighth (8<sup>th</sup>) motion for extension of time to file their initial brief. This motion was filed over eight full months from the filing of the Notice of Appeal. The continued delay of the appeal results in a continued delay of the trial of this matter. This continued delay is indifferent to the rights of the

Respondents in that Respondents have not be afforded the protection of Rule 1, South Carolina Rules of Civil Procedure, which provides for “the just, speedy, and inexpensive determination” of this matter. See McComas v. Ross, 368 S.C. 59, 63, 626 S.E.2d 902, 904 (Ct. App. 2006).

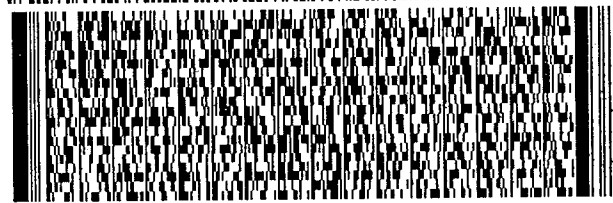

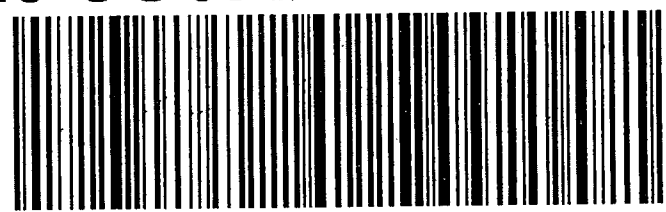
