**MOTION FOR SECOND EXTENSION OF TIME TO FILE

Counsel has also spent a substantial amount of time drafting the Initial Brief of Respondent in the matter of State vs. Billy Phillips, a direct appeal in a Jasper County murder case pending before the South Carolina Court of Appeals.

Counsel has also spent a significant amount of time reviewing the transcript and researching the issue in preparation for drafting the Initial Brief of Respondent in this matter. However, due to counsel's involvement in these and other matters pending in state and federal court, counsel is unable to timely complete the Initial Brief of Respondent and Designation of Matter in this proceeding.
