Carla Denise Garrison and Clint Garrison appeal the January 26, 2017 order of Judge R. Keith Kelly, which granted Target Corporation's motion for judgment as a matter of law with respect to punitive damages. The Garrisons received electronic notice of the order on January 26, 2017. Carla Denise Garrison and Clint Garrison also appeal the February 9, 2017 order of Judge R. Keith Kelly, which limited their recovery of prejudgment interest to the reduced award included the January 26, 2017 order rather than the jury's award. The Garrisons received electronic notice of the order on February 9, 2017.
