Appellant Bank of America, N.A. ("Bank of America") respectfully requests an extension of time in which to file its Reply to the Initial Brief of Respondent Katz until ten (10) days after both Respondents have filed their initial briefs. Counsel for Defendant-Respondent Katz submitted her Initial Brief and Designation of Matter of Record on Appeal ("Initial Brief") on November 2, 2012; however, Plaintiff-Respondent Jernigan has requested an extension of time until December 2, 2012 in which to file his Initial Brief. Due to scheduling and work conflict issues, counsel for Bank of America requires an extension of the current deadline to reply to Katz's Initial Brief. Additionally, the briefs of both Respondents will likely address similar issues of law and fact, and therefore, in the interest of judicial economy, Bank of America would prefer to file a single Reply Brief addressing the Initial Briefs of both Respondents.

Accordingly, Bank of America requests an extension in which to file its Reply to Katz's Initial Brief until ten (10) days after both Respondents have filed their initial briefs. Assuming Jernigan files his Initial Brief on December 3, 2012 (December 2 is a Sunday), Bank of America's Reply to the Initial Briefs of both Respondents would be due on or before December 13, 2012. This is Bank of America's first request for an extension of time in which to file its Reply.


