**AGREEMENT TO DISMISS APPEAL**




1. to the dismissal of the Appeal and remand of this matter to the lower court;
2. each party will bear its own costs in connection with this Appeal;
3. upon remand, the deadlines for Appellants to respond to the discover requests that were the subject of this Appeal are suspended while the parties attempt to gain further certainty regarding how Respondents' claims will proceed, both substantively and procedurally, in the lower court. Respondents may lift this suspension on thirty (30) days written notice to the

Appellants, at which time the response deadlines set by the January 11, 2016 lower court order on appeal shall begin to run. Appellants retain the right to move the lower court to further stay or extend the subsequent discovery deadlines on any proper grounds.



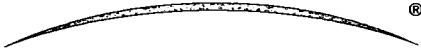


