In accordance with Rule 207, SCACR, we are writing to make arrangements regarding the transcripts in this case. A notice of appeal was filed on February 13, 2017.

It is our understanding that three proceedings were transcribed in the trial court: (1) an April 10, 2015, summary judgment hearing, (2) the September 5-8, 2016, trial, and (3) the


November 3, 2016, hearing on the parties' post-trial motions. We are in possession of copies of the transcripts from the trial and post-trial motions hearing, but we are not in possession of the transcript from the April 10, 2015, summary judgment hearing.

Please let us know the cost of the transcription and where prompt payment can be submitted. It is our understanding that, under Rule 207(a)(2), SCACR, the transcript should be delivered no later than sixty (60) days after the date of this request.

By way of this letter, we also request confirmation that the three transcripts referenced above constitute transcripts of the entirety of the proceedings from the trial court. If there are any other transcripts we have failed to mention, we ask that we be promptly alerted to the same.
