
We recently received George Cleveland's "Subsequent Application for Relief." According to the South Carolina Appellate case management system, the appeal against the Greenville County Sheriff's Office officially "ended" last year.

Mr. Cleveland attached an Order with the above-referenced appellate number recalling remittitur from the case of George Cleveland, #357770 vs. the South Carolina Department of Corrections. This separate appellate action an appellate case number of 2016 - 001033. In reviewing his "Subsequent Application for Relief" in appellate case number 2016 - 000498 against the Greenville County Sheriff's Office, the Plaintiff references the Administrative Law Court and the recall of a remittitur in the case of George Cleveland, III vs. SCDC, appellate case number 2016 - 001033. These are two separate and independent cases and an Order recalling remittitur in the case against the South Carolina Department of Corrections is irrelevant to the closed case of George Cleveland, III vs. the Greenville County Sheriff's Office 2016 - 000498.

We would ask that the Court deny Mr. Cleveland's "Application" as it is clearly not relevant to a closed appellate appeal. Please let me know if the Court requires a more formal response to Mr. Cleveland's "Application."
