MOTION FOR EXTENSION OF TIME TO FILE APPELLANT'S
INITIAL REPLY BRIEF

Appellant Stevens Aviation, Inc., hereby moves for an extension of the time in which to file its initial reply brief in this appeal. See Rule 263(b), SCACR. Specifically, Appellant requests an extension until ten days from the date the Court rules on Appellants motion to strike footnote one of the initial brief of Respondent, which is being filed contemporaneously with this motion.

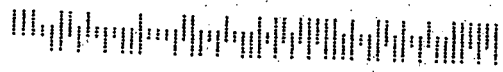
