MOTION AND ORDER FOR SUBSTITUTION OF COUNSEL





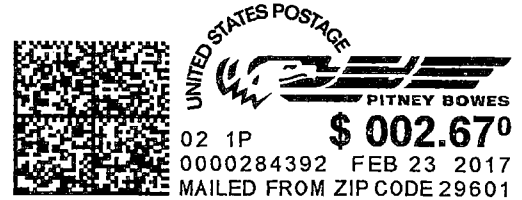
