
Dear Ms. Salen:

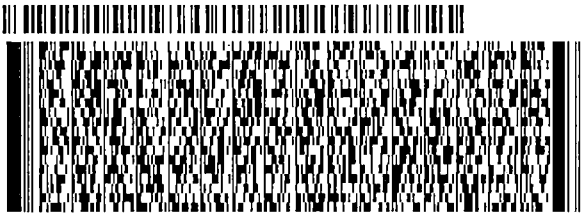

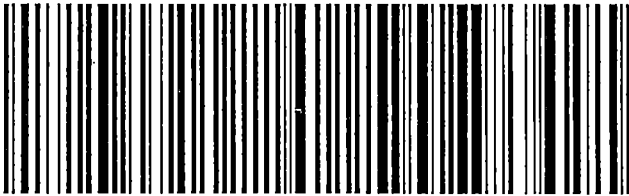
