

Counsel testified during a PCR hearing at the Beaufort County Courthouse in the case of Rodriguez Carter v. State on February 14, 2017. On February 10, 2017, counsel represented Donald Lamon Young at a reconstruction hearing before the Honorable J. Mark Hayes, II, in Greenville, South Carolina. Counsel filed the Anders brief of appellant and Record on Appeal in the case of State v. Leon James in the Court of Appeals on February 3, 2017. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Corey Geddie v. State in this Court on January 30, 2017. Counsel filed the Anders brief of appellant and Record on Appeal in the case of State v. Jason Gourdine in the Court of Appeals on January 27, 2017. Counsel filed the petition for rehearing in the case of State v. Wayne Gary Polite in the Court of Appeals on January 26, 2017. Counsel filed the Anders brief of appellant and Record on Appeal in the case of State v. Brandon Rashad Marshall in the Court of Appeals on January 24, 2017. Counsel filed the initial brief of appellant and designation of matter in the case of State v. James Miller in the Court of Appeals on January 18, 2017. Counsel filed the return to petition for rehearing in the case of State v. Walter M. Bash in the Supreme Court on January 17, 2017. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of State v. Tyrel Collins in the Supreme Court on January 3, 2017. Counsel filed the petition for rehearing in the case of State v. Keith Denver Tate in the Court of Appeals on December 29, 2016.

3. This request is made in good faith, and not for purposes of delay.


4. As indicated by her consent below, counsel for the state graciously consents to or does not oppose this request.


