
**AMENDED MOTION FOR EXTENSION OF



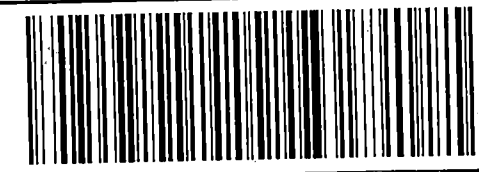
