

DESCRIPTION OF OFFENSE: Robbery / Armed Robbery, robbery while armed or allegedly armed with a deadly weapon

I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

On 5/17/16 Officers with the Myrtle Beach Police Department responded to 3791 Oleander Drive, a location within the city limits of Myrtle Beach for an armed robbery. The investigation revealed that the Defendant entered the store while armed with a deadly weapon, physically struck the Victim in the head numerous times with the weapon and took cash and cigarettes from the store. Given the above facts, the fact that the Victim was threatened at gunpoint and was assaulted with the firearm causing possible life threatening injuries requiring immediate medical care, and the fact that the Defendant did take away the property of another while armed with a deadly weapon there is probable cause to believe the Defendant did commit the above offense.
