State, 319 S.C. 59, 459 S.E.2d 838 (1995), and State v. Thrift, 378 S.C. 70, 661 S.E.2d 373 (2008).

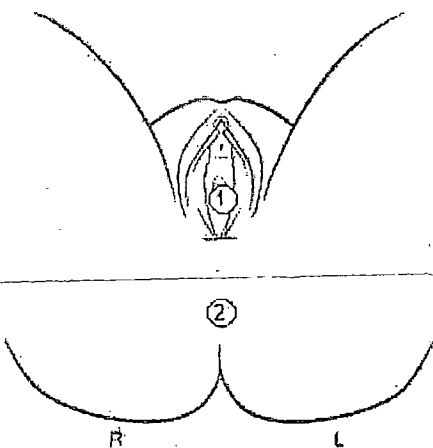

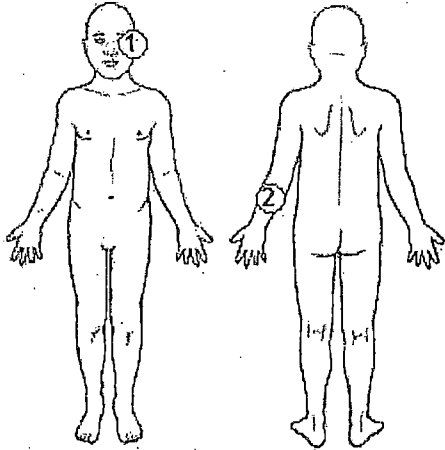


1: Annular, estrogenized hymen, no tears, no discharge, no scars

Gloria made a disclosure of sexual abuse involving alleged offender's oral contact with child's genitalia, child's oral contact with alleged offender's genitalia, digital/anal penetration, digital/vaginal penetration and penile/anal contact or penetration by Jerry. Additional concerns included threats by Jerry as well as aunt and boyfriend testing positive for methamphetamine and aunt not protecting Gloria.. Her physical exam was normal with no acute or chronic changes on anogenital exam. A normal exam does not rule out sexual abuse and could be consistent with allegations made.

I have tried to contact my caseworker and have not got a response.

I have spoken to Mrs. Evelyn twice on this matter and she said to send a letter to you in hopes that we can proceed please review my case and see there is no evidence against me, they tried me solely on her word, and never gave me a chance to fight. It is not possible to do what she said, I was in her way and she is smart. She knew how to get rid of me and she did.

I am doing a 20 yr sentence for a crime I did not commit. Please help me. I am fighting this alone. Other than the woman who raised the girl, Pamela Mullinax raised her and she can tell you how this girl was. The girl's whole family know I did not ever touch that girl. Please don't allow them to take my life away and I did not touch her.

Broad River is keeping me locked down so I cannot do my legal work on time and they are holding my legal work so I miss my dead lines.

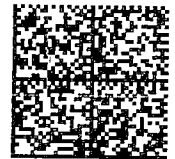
