ARMED ROBBERY

That Willie Thomas Starnes did in Kershaw County on or about August 24, 2013, commit robbery by feloniously taking from the person or presence of ALAN ROBINSON, by means of force or intimidation, goods or monies of ALAN ROBINSON, such goods or monies being described as MOPED, with the intent to deprive the owner permanently of such property, while armed with a pistol, dirk, slingshot, metal knuckles, razor, or other deadly weapon TO WIT, A MOTOR VEHICLE, or while alleging, either by actions or words, that he or she was armed while using a representation of a deadly weapon or any object which a person present during the commission of the robbery reasonably believed to be a deadly weapon. All in violation of §16-11-330(A), SC Code of Laws (1976, as amended)


This office is in receipt of the Remittitur in the above matter dated January 10, 2017.
