The petitioner, Korey Lamar Love, petitions this Court for an order extending the time to file his petition for writ of *certiorari* and the appendix.


- 1) The petition and appendix were due on March 1, 2017. This petition is Mr. Love's third request for an extension.
- 2) This post-conviction relief case involves a conviction for murder following a jury trial.
- 3) This request is not intended for delay. Because other professional obligations, counsel has not had time to complete the petition. Although the case ultimately resolved on March 2, 2017, counsel was scheduled to try a Department of Services child abuse and neglect case involving allegations of child sexual abuse on February 28 and March 2, 2017. Substantial preparation time was required in the weeks leading up to this scheduled trial.

Therefore, Mr. Love respectfully requests this Court issue and order extending the time to file the petition and appendix by thirty days to Friday, March 31, 2017.

Finally, counsel respectfully requests this Court accept this request out of time. Counsel overlooked sending this request last week because of his involvement in the possible DSS trial.

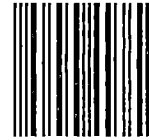
