Please Note I do have to hand write my copies do to the fact SCDC will not make copies of anything hand written.

I do know that ignorance should be no excuse. But I am ignorant when it comes to doing legal work.

I also ask that the court please note, I am legally blind. In fact I am completely blind in my left eye + partly blind in my right eye. I will be 64 years old in June, I have 10 electrical blocks in my heart, right + left side. I am under terrible living conditions in SCDC and tremendous stress do to a family matter. My mother is 90 years old with a heart condition and just been placed on dialysis 3 hours a day, 3 days a week.

My mother needs my help and I need the court's help. So I ask the court after almost 22 years in prison. I ask for mercy.

SCDC is with-out doubt in violation of policy OP 21.09, 11.4-11.7. that requires the agency MUST have a commitment order in order to have authority of law to hold a person in prison. I am being held under the color of law by this state agency. They have no commitment order signed by a judge. therefore they have no authority of law to hold me in prison under armed guard.

I apologize again to the court for my mistake.
