
the remand of this action to the Circuit Court in order to effectuate and/or enforce the terms of the global settlement agreement.



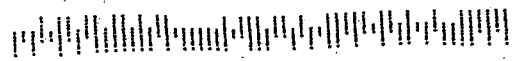
