The affiant states there is probable cause to believe that the defendant named above did commit the crime(s) set forth, and that such probable cause is based on the following facts:


That between April 8, 2009 and April 8, 2012, while at _____, which is located in the City of North Charleston, County of Charleston and State of South Carolina, the defendant, **Brian Christopher Daugherty**, did commit the offense of **Criminal Sexual Conduct With a Minor, First Degree**, in violation of Section 16-3-655(A) of the South Carolina Code of Laws of 1976, annotated. In that the defendant did willfully, unlawfully and feloniously engage in sexual battery with a minor. The female victim, to be identified in court, is currently eleven (11) years old. She was six (6), seven (7), and eight (8) years old during the abuse. The defendant is a thirty-six (36) year old male.

The facts to establish the aforesaid are that during the first week of February, 2015, the victim's mother and step-father overheard the victim and the victim's sister crying in one of their bedrooms. The step-father went in the bedroom to address the unknown issue and both the victim and her sister disclosed they had been sexually abused by the defendant at the above listed incident location. The step-father advised the victim's mother what he had just been told, and the victim's mother then made contact with the victim and the victim's sister, who are both her children. When she entered the bedroom she observed both female juveniles on the bed hugging and crying. The victim disclosed to her mother that when they resided in the same home with the defendant, he would watch pornographic movies with her and then ask if she wanted to do what the people in the movies were doing. When she said "No" the defendant forced her to perform oral sex on him and threatened her if she didn't comply. The victim's sister advised that she was sexually abused by the defendant as well when they resided with him.

On February 17, 2015, the victim was seen by a Therapist at the Dorchester County Children's Center for a forensic interview. The victim disclosed that when she was six (6), seven (7) and eight (8) years old, and while residing with the defendant (her Aunt's Fiancé at that time), the defendant sexually abused her. She disclosed the defendant would call her into his bedroom and show her "porn" on the computer. "Porn" was established to mean a movie consisting of a male(s) and female(s) in a movie engaging in oral sex and sexual intercourse. The defendant would then ask the victim if she wanted to do the same things the people in the movies were doing. The victim stated she would say "no" and try to leave, but the defendant would prevent her from leaving, "slam" her on his bed, push her down, and threaten her. The victim disclosed the defendant digitally penetrated her vagina, kissed and licked her vagina, and forced her to perform oral sex on him. She disclosed the defendant would "choke" her and "gag" her if she refused, screamed, or made noise. The victim also disclosed the defendant tried one time to put his penis inside her vagina but he stated it was "too big". She reported he put a condom on his penis, spread her legs apart and tried to "force" it in. The victim's sister was also seen at DCC and also disclosed sexual abuse by the defendant.

This information is based upon the investigation of Det. R. Bailey with the North Charleston Police Department. Therapist Danielle Nickles with the Dorchester Country Children's Center, Lisa Batten, Benson Gomez, the victim's sibling, and the victim are witnesses to prove the same. All done against the law, peace and dignity of the State of South Carolina.

CRIMINAL SEXUAL CONDUCT WITH A MINOR, FIRST DEGREE
VIOLATION OF SECTION 16-3-655(A)(1)**

The affiant states there is probable cause to believe that the defendant named above did commit the crime(s) set forth, and that such probable cause is based on the following facts:

That between February 18, 2008 and February 18, 2010, while at _____, which is located in the City of North Charleston, County of Charleston and State of South Carolina, the defendant, **Brian Christopher Daugherty**, did commit the offense of **Criminal Sexual Conduct With a Minor, First Degree**, in violation of Section 16-3-655(A) of the South Carolina Code of Laws of 1976, annotated. In that the defendant did willfully, unlawfully and feloniously engage in sexual battery with a minor. The female victim, to be identified in court, is currently sixteen (16) years old, but was younger than eleven (11) years old during the abuse. The defendant is a thirty-six (36) year old male.

The facts to establish the aforesaid are that during the first week of February, 2015, the victim's mother and step-father overheard the victim and the victim's sister crying in one of their bedrooms. The step-father went in the bedroom to address the unknown issue and both the victim and her sister disclosed they had been sexually abused by the defendant at the above listed incident location. The step-father advised the victim's mother what he had just been told, and the victim's mother then made contact with the victim and the victim's sister, who are both her children. When she entered the bedroom she observed both female juveniles on the bed hugging and crying. The victim disclosed to her mother that when they resided in the same home with the defendant, he would watch pornographic movies with her and then ask if she wanted to do what the people in the movies were doing and specifically asked her if he could put his penis in her mouth. The victim told her mother the defendant penetrated her vagina with his fingers and made her touch his penis

On February 17, 2015, the victim was seen by a Therapist at the Dorchester County Children's Center for a forensic interview. The victim disclosed she was sexually abused by the defendant during the time frame established above, when they resided together at the incident location listed above. She disclosed the defendant, at first, treated her like a "friend" by talking to her about her problems, allowing her to "curse" and taking her places. She disclosed the defendant then started touching her breasts and vagina both under and over her clothing and that he would kiss her. She disclosed the defendant began digitally penetrated her vagina and specified that he would move his fingers in and out of her vagina. She also disclosed the defendant would watch pornographic movies in her presence, that he would expose his penis and make her "stroke" it, and that he made her sit on top of his penis while she was nude and "grind" on it. She described his penis as "getting wet at the tip." The victim's sister was also seen at the Dorchester County Children's Center for a forensic interview, and also disclosed sexual abuse by the defendant

This information is based upon the investigation of Det. R. Bailey with the North Charleston Police Department, Therapist Danielle Nickles with the Dorchester Country, Children's Center, Lisa Batten, Benson Gomez, the victim's sibling, and the victim are witnesses to prove the same. All done against the law, peace and dignity of the State of South Carolina.



The victim disclosed that during the established time frame above, while residing with the defendant at the listed incident location, the defendant touched her breasts and vagina both over and under her clothing. She disclosed he would hug her, "grab" her buttocks and kiss her. The victim disclosed the defendant would expose his genitals and make the victim "stroke" his penis with her hands. The victim also disclosed the defendant would make her take her pants and underwear off, sit on top of his exposed penis, and "grind" on him. The victim reported the defendant's penis would be "wet at the tip."

This information is based upon the investigation of Det. R. Bailey with the North Charleston Police Department. Therapist Danielle Nickles with the Dorchester Country Children's Center, Lisa Batten, Benson Gomez, the victim's sibling, and the victim are witnesses to prove the same. All done against the law, peace and dignity of the State of South Carolina.
