
This case was tried before the Honorable Frank R. Addy, Jr. and a jury beginning on March 14, 2017.

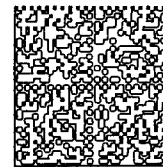
