MOTION FOR AN EXTENSION OF TIME
IN WHICH TO FILE THE PETITION FOR WRIT OF

Counsel filed the brief of petitioner in the case of Jerod Keykendall Harris v. The State of South Carolina in the Supreme Court on March 7, 2017. Counsel filed the initial brief of appellant and designation of matter in the case of The State v. Mark Anthony Bayne with the Court of Appeals on February 21, 2017. Counsel filed the initial brief of appellant and designation of matter in the case of The State v. Garrick Epps with the Court of Appeals on February 16, 2017. Counsel filed the petition for writ of certiorari to the Court of Appeals and accompanying appendix in the case of Donte Samar Brown v. The State of South Carolina in the Supreme Court on February 9, 2017. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of DeAngelo Mitchell v. The State of South Carolina in the Supreme Court on February 6, 2017. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Maurice Wilson v. The State of South Carolina in the Supreme Court on February 6, 2017. Counsel filed the initial brief of appellant and designation of matter in the case of The State v. Theia Darion McArdle with the Court of Appeals on January 27, 2017.

4. Counsel makes this request in good faith and not for purpose of delay. Counsel intends to continue to work on the cases with more than three extensions first so that the caseload will hopefully become more manageable in the near future, and less extensions will need to be requested.

5. Counsel for the Attorney General's office consents to this request as shown by signature below.




