COME NOW Respondents, Mansour Rashtchian and Amy Rashtchian (collectively "Respondents"), by and through their undersigned counsel, pursuant to Rule 263(b), SCACR, and on the grounds set forth below, hereby move this Honorable Court for an extension of ten (10) days time to file a return to the petition for rehearing of this matter.



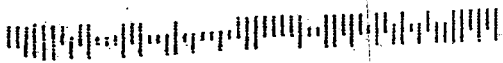
