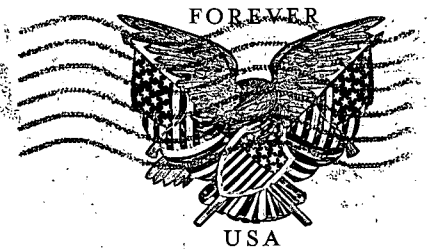
I am writing you in reference of
