SEXUAL EXPLOITATION OF A MINOR,  
SECOND DEGREE

At a Court of General Sessions, convened on \_\_\_\_\_, 2016, the  
Grand Jurors of Greenville County present upon their oath:

That Jason Skyler Israel Pogue, on or about March 11, 2015, did willfully and knowingly, commit the crime of Sexual Exploitation of a Minor, Second Degree. To wit: Jason Skyler Israel Pogue, did knowingly distribute, transport, exhibit, receive, sell, purchase, exchange, and/or solicit material in the video file titled "pthc\_ptsc jenny\_9yo daughter asking for cum, new.avi" that contains a visual representation of a minor engaged in sexual activity or a minor appearing in a state of sexually explicit nudity when a reasonable person would infer the purpose is sexual stimulation, as defined by Sections 16-15-375(5) and Section 16-15-375(6) of the South Carolina Code of Laws. This incident occurred within the County of Greenville, State of South Carolina, and is in direct violation of Section 16-15-405(A) of the South Carolina Code of Laws (1976), as amended.
