


MOTION FOR EXTENSION



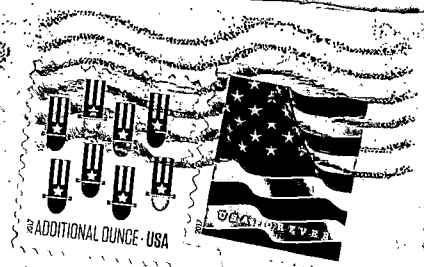
