MOTION TO DISMISS APPEAL

Pursuant to Rule 240, S.C.A.C.R., the Respondent, by his counsel herein, moves this Court for a dismissal of the Appeal, on the grounds stated below.

Joann A. Wright appealed to the circuit court from a decision of the Resolution of Fee Disputes Board. The circuit court dismissed the appeal and denied Wright's motion to reconsider. She now appeals to the South Carolina Court of Appeals (i) Judge S. Jackson Kimball III's Order dated February 22, 2017, and (ii) the Order on Defendant's Motion to Reconsider dated March 14, 2017.

The Court of Appeals does not have jurisdiction to review this appeal. *Wright v. Dickey*, 370 S.C. 517, 636 S.E.2d 1 (Ct. App. 2006).

The respondent moves to dismiss the appellant's appeal for lack of jurisdiction.

WHEREFORE, the Respondent herein moves that this Court be dismissed, as set out above, pursuant to Rule 240, S.C.A.C.R.


