

Enclosed please find my Notice of Appearance as the attorney for the Appellant in this case, Barbara A. Goodwin.



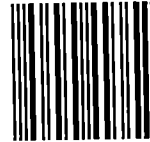
