**NOTICE OF APPEAL**

On June 9, 2015, Jeanette Glover was tried in Orangeburg Municipal Court before the Honorable Barney Houser and a jury. She was convicted of Criminal Domestic Violence and sentenced to 30 days or \$2130.00 cash suspended upon completion of CASA. On June 10, 2015, Jeanette Glover appealed her conviction and sentence. On September 28, 2015, the Honorable Maite Murphy presided over oral arguments. On April 7, 2016, Judge Murphy filed her opinion affirming Glover's conviction in Municipal Court, of which Counsel was noticed on January 13, 2017. On January 20, 2017, Counsel filed a Motion to Reconsider. On March 30, 2017, Judge Murphy filed her opinion denying the Motion to Reconsider, of which Counsel was noticed on April 7, 2017. Jeanette Glover appeals.



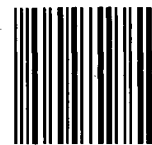
