
MOTION FOR EXTENSION



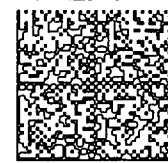

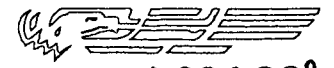
