**PETITION FOR EXTENSION TO FILE

Counsel filed the initial brief of appellant and designation of matter in the case of State v. Robert D. Smith in this Court on March 6, 2017. Counsel filed the petition for writ of certiorari to this Court in the case of State v. Abdul Furquan in the Supreme Court on February 27, 2017. 3. This request is made in good faith, and not for purposes of delay.


4. As indicated by his consent below, counsel for the state graciously consents to or does not oppose this request.
