At a Court of General Sessions, convened on _____ the
Grand Jurors of Spartanburg County present upon their oath:

ARMED ROBBERY

That Shiquan Antwain Coepland, did in Spartanburg County on or about January 9, 2016, while armed, or while alleging, either by action or words, he was armed while using a representation of a deadly weapon or any object which a person present at the time reasonably believed to be a deadly weapon, to-wit: the defendant, armed with a firearm, did feloniously take possession of and carry away a wallet and a cell phone, from victim [REDACTED], with intent to deprive the owner permanently of such property, and that the defendant did leave Lindsey Baker with immediate possession of the goods or property, and by means of force or intimidation, used the deadly weapon to facilitate escape, in violation of §16-11-330 (A), *THE CODE OF LAWS OF SOUTH CAROLINA*, (1976, as amended).
