

IT IS HEREBY ORDERED that the Defendant Barron S. Nason is in contempt of this Court's Order issued November 23, 2016. After hearing evidence from both parties and testimony from the Defendant, the Court finds the Defendant has disposed of his assets in excess of that needed to support his household. The Court hereby required Defendant to make payment of Sixty Thousand (\$60,000.00) Dollars for violating the previous Order of this Court. The Defendant will pay to the Plaintiff in good funds Ten Thousand (\$10,000.00) Dollars by February 1, 2017. The Defendant will make five (5) additional Ten Thousand (\$10,000.00) Dollar-payments on the first day of each successive month beginning March 1, 2017. The monthly payments beginning on February 1, 2017 shall have a five (5) day grace period. If the Defendant fails to make the payments required herein, the Plaintiff may file a Rule To Show Cause for additional sanctions for contempt.


