DEAR JUDGES TOAL,

I WROTE YOU IN 2012 TO HELP ME GET TO TRIAL BECAUSE THE DARWININGTON COURT KEPT STALLING BECAUSE THEY HAD NO EVIDENCE. YOU DID GET THEM TO FINALLY TAKE ME TO TRIAL. I WAS WAITING A YEAR AND A HALF BEFORE I WROTE YOU TO SEE IF YOU MIGHT BE ABLE TO GET THIS COURT TO FINISH THEIR PROSECUTION. WELL... AT TRIAL IT WAS PROVEN THE ALLEGED VICTIMS TESTIFIED I DID NOT SHOW NUDE PHOTOS OF MYSELF TO THEM AS MINORS, BUT MY PUBLIC DEFENDER LET THE PROSECUTOR BUILD AN "INTENT" CASE IN AND STRAIGHT OF THE TRIAL AND THE SURV BOUGHT HIS ARGUMENT. I DID NOT KNOW YOU COULD BE FOUND GUILTY BY "INTENT" UNTIL A YEAR LATER IN THE STATE PRISON LAW LIBRARY.

I WAS SENTENCED TO 90 DAYS NON VIOLENT, BUT SIX MONTHS BEFORE MY EARLY RELEASE I WAS, WITHOUT ADVANCE NOTICE, TAKEN BACK TO ORANGE COURTHOUSE TO A HEARING WHERE I WAS ASSIGNED AN ATTORNEY 15 MINUS. BEFORE ENTERING THE COURT ROOM TO BE ORDERED TO TAKE S.V.P. EVALUATION TEST TO BE CIVILLY COMMITTED.

MY DIRECT APPEALS WAS A SHAMBLE BECAUSE THE ASSIGNED ATTORNEY DID NOTHING TO DEFEND MY WRONGFUL CONVICTIONS. SAME WITH MY P.C.R. INEFFECTIVE ASSISTANCE OF COUNSEL.

I WAS DENIED MY P.C.R. ~~NO~~ 11-2-2016 AND SIX MONTHS LATER I HAVE NOT BEEN ASSIGNED AN ATTORNEY FOR MY APPEALS. MY ATTORNEY TURNED IN THE NOTICE ON NOV. 22. 2016. C/A NO. 2015-CR-16-16

IS IT POSSIBLE YOU MIGHT BE ABLE TO FIND OUT WHY THE APPEALS COURT IS TAKING SO LONG TO HEAR MY CASE. I'M NOT EXPECTING ANYTHING DIFFERENT THAN THE OTHER COURT DECISIONS. I MUST EXHAUST STATE REMEDIES FIRST AS YOU KNOW.

SO PLEASE HEAR ME TO SPEED THINGS UP. I WOULD LIKE TO SPEND A FEW DAYS WITH MY MOTHER BEFORE SHE IS GONE.

I THANK YOU IN ADVANCE FOR WHAT EVER IS IN YOUR AUTHORITY TO DO FOR MY SITUATION.

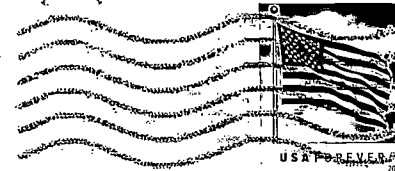
