

If you would like to receive a hard copy of the transcript, please include an additional \$7.00 for postage fees. The transcript will be mailed as a priority delivery through the USPS.

Under the State rules, I have sixty (60) days to complete the transcript, after receipt of deposit. In addition, I am allowed to request from Court Administration thirty-day extensions, if necessary, to complete the transcript. You will be notified if extensions are granted.

If you desire to cancel the request for the transcript, a cancellation request must be made in writing. You will be responsible for payment of any portion of the transcript that has been completed.
