MOTION TO FILE THE PETITION FOR WRIT OF CERTIORARI  
AND APPENDIX OUT OF TIME

Counsel for David Austin Land, respectfully moves the Court to allow the Petition for Writ of Certiorari and Appendix to be filed out of time. In support of this Petition, Counsel shows:


- (1) The Petition for Writ of Certiorari and accompanying Appendix in this case were due to be filed with the Court on April 24, 2017.
- (2) The case was inadvertently failed to calendar this Petition as due on April 24, 2017.
- (3) Counsel failed to file the Petition and Appendix in a timely manner.
- (4) Counsel filed for an extension on April 26, 2017, under the mistaken belief the Petition for Writ of Certiorari was due on that date.
- (5) Upon a later review of the emails in this matter, the attorney for Petitioner realized that he received an electronic copy of the Order denying rehearing on March 24, 2017. He received a hard copy of the Order on March 27, 2017. Furthermore, upon

a review of the rules, the Petition for Writ of Certiorari is due ~~30~~ days after the Order denying the rehearing petition is filed and not from the date of receipt by counsel for the Petitioner.

- (4) The Attorney for the Petitioner has contacted William M. Blich, Jr. and he has no objection to the request to file the Petition for Writ of Certiorari and the Appendix out of time.




