**SELF-DEFENSE**

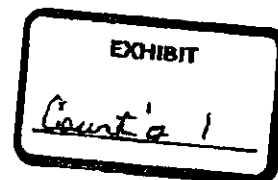
**Request to Charge No. 1**

Ladies and gentlemen of the jury, Kadrin Singleton has offered evidence of having acted in self-defense when he shot Sharrell Williams. And ladies and gentlemen of the jury, I charge you that self-defense is a complete defense to the charge Murder.

I charge you that in deciding whether Kadrin Singleton is guilty or not guilty of Murder, the State has the burden of proving beyond a reasonable doubt, that he did not act in self-defense.

In other words, if you have a reasonable doubt about whether Kadrin Singleton was acting in self-defense, you are to resolve that doubt in his favor and find him not guilty.

*State v. Burkhardt*, 350 S.C. 252, 565 S.E.2d 298 (2002); *State v. Davis*, 282 S.C. 45, 46, 317 S.E.2d 452, 453 (1984).



Request to Charge No. 2

There are four elements required by law to establish self-defense in this case. The first element is that Kadrin Singleton must be without fault in bringing on the difficulty.

The second element is that Kadrin Singleton must have actually believed he was in imminent danger of losing his life or sustaining serious bodily injury, or he actually was in such imminent danger.

Third, if Kadrin Singleton's defense is based upon his belief of his being imminent danger of suffering a serious bodily injury or death, a reasonably prudent man of ordinary firmness and courage would have entertained the same belief.

If Kadrin Singleton actually was in imminent danger, the circumstances were such as would warrant a man of ordinary prudence, firmness and courage to strike the fatal blow in order to save himself from serious bodily harm or losing his own life.

The fourth element is that Kadrin Singleton had no other probable means of avoiding the danger of losing his own life or sustaining serious bodily injury than to act as he did in this particular instance.

*State v. Davis*, 282 S.C. 45, 46, 317 S.E.2d 452, 453 (1984).

Request to Charge No. 3

In this case, Kadrin Singleton has offered evidence that he believed he was in imminent danger of death or of receiving serious bodily harm. If Kadrin Singleton's belief was reasonable, he does not have to wait until he is actually attacked or injured or until force is used by the aggressor before he exercises his right to use deadly force in self-defense.

In other words, Kadrin Singleton does not have to wait until the assailant "gets the drop on him" in order to be entitled to use force in self-defense.

*See* F. PATRICK HUBBARD, JURY INSTRUCTION FOR CRIMINAL CASES IN SOUTH CAROLINA: DEFENDANT'S REQUESTED INSTRUCTIONS 265-298 (2d ed. 2001).

Request to Charge No. 4

In determining whether Kadrin Singleton's belief of being in imminent danger of death or of receiving serious bodily harm was reasonable, you should try as near as you can to put yourself in his situation at the time of this incident because people are entitled to act on appearances.

You should consider the circumstances by which Kadrin Singleton was surrounded, and take into consideration the person with whom he was dealing, and all of the facts which surround him, as you obtained the same from the testimony, and as near as you can, view the situation from the Defendant's standpoint.

I further instruct you that you are not to determine if Kadrin Singleton made the wisest choice possible, but only a reasonable one under the circumstances as he perceived them.

Request to Charge No. 5

In determining whether Kadrin Singleton's belief of being in imminent danger of death or of receiving serious bodily harm was reasonable, I instruct you that you may consider the following factors:

You may consider whether Kadrin Singleton's belief of being attacked by Mr. Williams was a reasonable belief when there were words accompanied by hostile acts. I further charge you that that words accompanied by hostile acts may be sufficient alone to establish that Kadrin Singleton acted in self-defense.<sup>1</sup>

Request to Charge No. 6

Ladies and gentlemen of the jury, the prosecution has offered evidence that Kadrin Singleton shot Mr. Williams more than once. I charge you that "ordinarily one is not justified in . . . employing a deadly weapon after the adversary has been disarmed or disabled. However, when a person is justified in [using deadly force], he is justified in continuing to [use deadly force] until it is apparent that the danger to his life and body has ceased."

*State v. Hendrix*, 270 S.C. 653, 661, 244 S.E.2d 503, 507 (1978) (internal quotation marks and citations omitted).

Request to Charge No. 7

Without fault means that “if the defendant’s conduct was the type with was reasonably calculated to and did provoke a deadly assault, the defendant would be at fault in bringing on the difficulty and would not be entitled to an acquittal on self-defense.”

*State v. Rye*, 375 S.C. 119, 651 S.E.2d 321 (2007); *State v. Dickey*, 394 S.C. 491, 716 S.E.2d 97 (2011).




