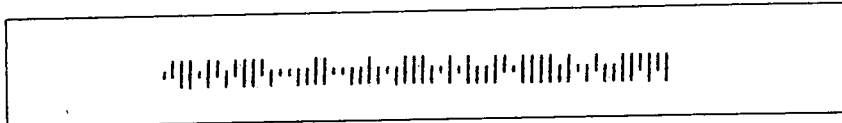
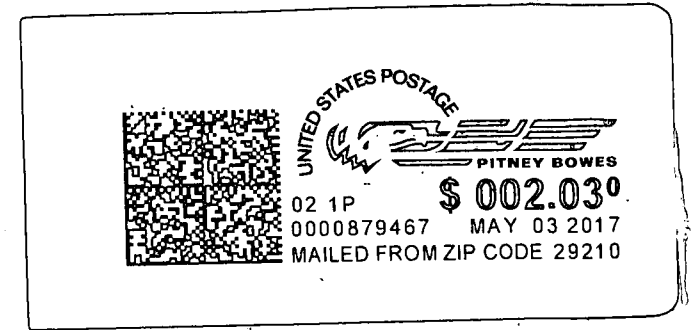
OF Law. Again I'm NO Lawyer. And I need
