Dear Ms. Kitchings:

We are in receipt of Appellant Reginald Evans' fax and letter dated May 1, 2017 concerning the Record on Appeal in the above-referenced matter. However, Respondents have not been served with the Record on Appeal, which is Appellant's obligation under Rule 210, SCACR. According to our records, the Record on Appeal was due to be served on Respondents on or before May 1, 2017.

What Appellant provided both on April 20, 2017 and on May 1, 2017 was a copy of the list of items he proposes to include in the Record on Appeal, but not the Record itself. It is possible that Mr. Evans misunderstands that this Court's appellate rules place the requirement on him, as the Appellant, to provide a Record that contains copies of all of the documents properly designated by any party to the appeal. Rule 210(c), SCACR. Given this apparent misunderstanding, Respondents do not oppose an extension of time for Appellant to compile and provide the Record as required by the rules. Respondents are unable to prepare their Final Brief until they receive a copy of the Record from Appellant.

In addition, Respondents again note that, while the Record on Appeal should include information for all attorneys representing parties to the appeal, the same is not true for Appellant's Final Brief. Thus, while both Amanda Mellard, Esq. and the undersigned should be listed as counsel for Respondents on the cover of the Record on Appeal, neither should be listed on the cover of Appellant's Final Brief.

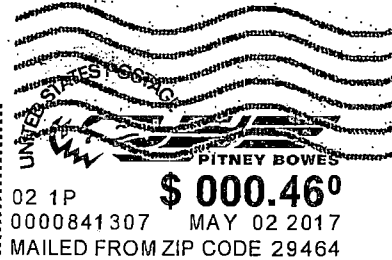
