
Dear Madam Clerk:

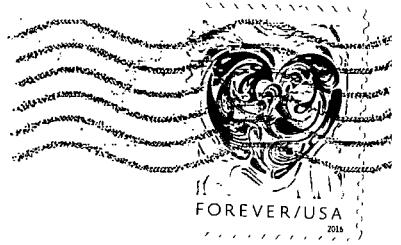
