MOTION FOR AN EXTENSION OF TIME



Counsel filed the petition for writ of certiorari to the Court of Appeals in the case State v. Michael Edwards Williams with this Court on March 22, 2017. Counsel filed the petition for writ of certiorari to the Court of Appeals in the case State v. Quartis Naquan Hemingway with this Court on March 22, 2017. Counsel filed the Petition for Writ of Certiorari in the case of Garvin V. Duvall v. State with this Court on March 17, 2017.

4. Counsel makes this request in good faith and not for purpose of delay.

5. Counsel for the Attorney General's office has been informed of this request.

WHEREFORE, the undersigned counsel would respectfully request a thirty day extension, in which to file the petition for writ of certiorari and appendix in this case based upon the above exigent circumstances. Counsel requests that time limits for filing the petition be held in abeyance pending a ruling on this motion.


