MOTION FOR EXTENSION OF TIME

Pursuant to 240 of the South Carolina Appellate Court Rules, Appellant Frances Arthur Oxner moves this Court for an order granting a ten (10) day extension of time to file the Initial Reply Brief of Appellant in this matter. 


