To Whom It May Concern:

Our firm represents Blue Ridge Electric Cooperative, Inc., and I am writing in regard to the above-captioned action in the Greenville Court of Common Pleas that was eventually appealed to the South Carolina Supreme Court.

In accordance with the Supreme Court's order of February 8, 2017 awarding costs to Ms. Gresham, we twice attempted to forward Ms. Gresham her court costs and damage award by U.S. Mail, certified delivery (once with return receipt requested and once without). Both of those attempts (sent February 10 and March 20, 2017, respectively) have been returned to us stamped "Return to Sender; Unclaimed; Unable to Forward." On May 11, 2017, we re-sent the original correspondence and check to Ms. Gresham a third time via Federal Express overnight delivery to her address that is on file with the court (this time not requiring any acceptance signature at delivery).

In an abundance of caution, we have enclosed courtesy copies of the following to ensure that our client's efforts to deliver these items to Ms. Gresham are documented with the courts:

1. Copies of certified mailing envelopes reflecting unclaimed deliveries dated March 2 and April 18, 2017;
2. Federal Express tracking and delivery information for most recent retransmission of correspondence and court costs; and


