

INORDINATE DELAY

THE ABOVE PETITIONER RESPECTFULLY MOVES UPON THE HONORABLE COURT TO PETITION AGAINST THE RESPONDENT FOR INORDINATE DELAYS.

1) THE PETITIONER FILED HIS PETITION FOR WRIT OF CERTIORARI ON JANUARY 18, 2017,

2) THE RESPONDENT WAS GIVEN THIRTY (30) DAYS TO ANSWER THE PETITION WHICH WAS FEBRUARY 19, 2017.

3.) THE RESPONDENT FAILED TO MEET THIS DEAD-LINE AND REQUESTED THIRTY (30) DAY EXTENSION, THAT WAS GRANTED UNTIL MARCH 20, 2017.

THE PETITIONERS RIGHT.


