
MOTION TO EXTEND TIME TO FILE APPELLANTS'

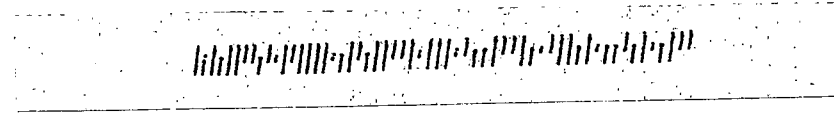
