

On November 30th, 2015 in the Myrtle Beach section of Horry County the defendant, David Harold Campbell, was found in possession of two clear plastic bags containing a white powder substance that field tested positive for cocaine. The substances were located after a vehicle chase of the defendant during a lawful traffic stop for a violation of failure to signal. The defendant wrecked the vehicle and ran with the narcotics when he was surrounded by officers he threw the narcotics to the second floor of the breezeway before being arrested. Officers located the two clear plastic bags of white powder substance right after taking him into custody. The approximate weight of the packages were 6.4 grams and 7.0 grams.
