

**MOTION FOR EXTENSION OF TIME TO FILE PETITION FOR WRIT
OF CERTIORARI TO SUPREME COURT OF SOUTH CAROLINA**

Pursuant to Rules 242 and 263, SCACR, Appellants Rick Still, Donice Still, Christine Orr and Terry Orr (Appellants) hereby move this Court for an Order granting a fourteen (14) day extension of time in which to file a Petition for Writ of Certiorari to the Supreme Court of South Carolina. On February 8, 2017, the Court of Appeals issued an Unpublished Opinion (Op. 2017-UP-068) affirming the decision of the trial court. Petitioners filed a timely Petition for Rehearing with the Court of Appeals. By Order dated May 8, 2017, the Court of Appeals denied the Petition for Rehearing. Pursuant to Rule 242 and 263, SCACR, the deadline for filing a petition for Writ of Certiorari is June 8, 2017. Appellants have not been served with a notice of the denial and recently learned of it when checking the Court of Appeals online records in this matter. Based on a heavy work load, Appellants respectfully request a fourteen (14) day extension of time in which to file their Petition for Writ of Certiorari. No further delays or extension requests are anticipated.




