BASED ON AN INVESTIGATION BY THE ORANGEBURG COUNTY SHERIFF'S OFFICE, THE DEFENDANT, MICHAEL LORENZO GREEN DID WITH MALICE AND FORETHOUGHT VIOLATE SECTION 16-3-10 OF THE SOUTH CAROLINA CODE OF LAWS, MURDER, IN THAT ON 11/28/2015 WHILE ARMED WITH A HANDGUN, THE DEFENDANT DID SHOOT THE VICTIM (FRANKLIN DEGREE) IN THE CHEST CAUSING HIS DEATH. THE DEFENDANT WAS POSITIVELY IDENTIFIED AS THE SHOOTER BY A WITNESS IN THIS CASE. THIS INCIDENT DID OCCUR AT 1690 BELLEVILLE RD IN ORANGEBURG, S.C.
