I like for the Supreme Court of South Carolina to know I do not have access to South Carolina state law rules of Court.

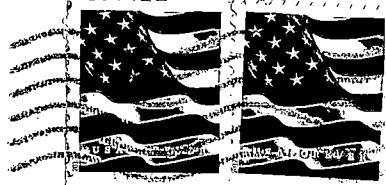
