
This appeal arises out of the denial of a Rule 29(b), SCRCrimP, motion. Undersigned counsel was retained to represent the Appellant in an appeal to the Court of Appeals but not to this Court. Furthermore, undersigned counsel's retainer fee was paid; however, only one minimal payment was made subsequently to the retainer despite undersigned counsel's repeated warnings, both in writing and in person, to the Petitioner that he would move to be relieved as counsel if the fee was not paid in full.

The Court of Appeals affirmed the circuit court's ruling in an opinion filed March 8, 2017. See State v. Choice, Op. No. 2017-UP-109 (S.C. Ct. App. filed March 8, 2017). The Petitioner timely filed for rehearing, which was denied on May 1, 2017. The Petitioner has the option to pursue an appeal to this Court. In order to preserve the Petitioner's right to do so, undersigned counsel respectfully requests that this Court relieve him as counsel and permit the Petitioner to proceed either *pro se* or through another attorney. In accordance with Rule 264(b), SCACR, undersigned counsel is serving a copy of this motion on both opposing counsel and the Petitioner on today's date. Undersigned counsel would also request that the time limits for filing the certiorari petition and appendix be stayed pending the resolution of this motion.

**CONCLUSION**

WHEREFORE, having set forth his grounds, undersigned counsel respectfully requests that this Court relieve him as counsel in this matter pursuant to Rule 264, SCACR.



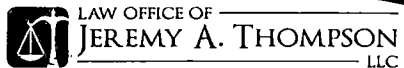

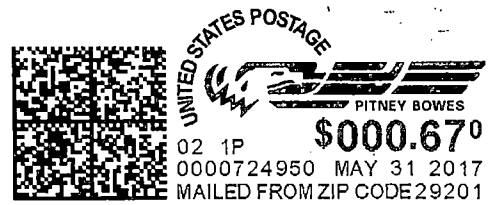
