

NOTICE OF APPEAL

Perez A. Brooks appeals his pleas of nolo contendere to the above charges of felony driving under the influence, resulting in death and reckless homicide, as well as his sentences in this case. The sentences were imposed by the Honorable R. Knox McMahon on May 25, 2017. Pursuant to Rule 211(b) and 211(d)(1)(B)(iv), SCACR, the ground for this appeal is that the defendant's plea was not knowingly, voluntarily, and intelligently made. Pursuant to *Anders v. California*, 386 U.S. 738 (1967) and *State v. Williams*, 305 S.C.116, 406 S.E.2d 357 (1991), counsel believes that the appeal does not meet the requirements of Rule 211(d)(1)(B)(iv) and moves to be relieved as counsel for Perez A. Brooks and to have counsel appointed or allow the defendant to proceed pro se with this appeal.




